According to @Newsjorf, the Coalition carried out raids on the <b>grain silos area of Hunaida</b>. Rasd-Sy also mentioned ‘mutual artillery exchanges’ between ISIL and SADF ground forces – though it was unclear whether this specifically referred to Hunaida.
