Allegation Description	<p>Estimated Casualties – Killed: unknown, Injured: 2</p> <p>Source #1: March 31st 2017: Raqqa city, Raqqa governorate, Syria Summary: According to the Smart News Agency, two civilians were wounded in an alleged Coalition airstrike on Raqqa. Smart reported: “A local source told the Smart correspondent on Friday that 10 members of the Islamic State were killed and wounded, in addition to the wounding of two civilians by the bombing of warplanes likely to be the coalition on the city of Raqqa. “The source pointed out that the aircraft launched raids on the old cultural center, the governor’s building and the central bank in the city of Raqqa, killing four members of the organization and wounding six others, who were transferred to the National Hospital of Raqqa, according to a medical source, in addition to wounding two civilians.” Civilians reported killed: Unknown Civilians reported injured: 2 Sources: Smart News Agency [Arabic], [Archived], Raqqa is Being Slaughtered Silently (RBSS) Arabic], [Archived], Quality of reporting: Weak – currently single source</p> <p>RFI Response: The source did not specify between the locations mentioned when discussing the wounding of civilians. However, the locations are all in the center of Raqqah: Old cultural center (القديم الثقافي المركز)x: 35.951112, 39.009489 [exact location] the governor's building (المحافظ مبنى)x: 35.945517, 39.011099 [exact location] the central bank (المركزي البنك)x: 35.941667, 39.010823 [exact location]</p>
