Source #1: February 26th 2017: الكور Al-Kour and other neighbourhoods at the right side of Mosul, Nineveh province, Iraq Summary: Local sources said that 33 civilians, including women and children, were killed and 35 injured due to Coalition airstrikes and artillery bombing on several neighborhoods at the right side of Mosul. Journalists had reported to Yaqein that “aerial bombardment and artillery [shelling] targeted violently, today, the homes of civilians in areas at the right side of the city of Mosul, killing 33 civilians, including women and children, and injuring more than 35 others” and added that “retaliatory shelling also caused the destruction of a number of civilian houses and damaged other.” Sonawa1 reported a large number of victims in Al-Kour neighbourhood at the right side of Mosul, due to artillery and airstrikes. According to Ajel al Mosul, the intended target may have been the Ekadat oil and gas station.
